LERP Call for Recruitment—Autoimmune Project

Occupational and environmental impacts on auto immunity have been a significant public health concern. Although there are genetic factors that affect development of some autoimmune diseases in certain individuals, population studies have shown an association between exposure to airborne particles (like asbestos) that may trigger or accelerate an autoimmune response.

Asbestos exposure is associated with various lung conditions, including fibrosis (lung scarring), pleural plaques, and cancer. Although the exact mechanisms leading to the progression of these conditions have not been fully explained, there is evidence that some of the lung abnormalities seen in asbestos related diseases (ARD) are caused by the body's own immune response. However, much more research is needed to determine the mechanisms linking exposure to asbestos and the development of an autoimmune disease such as rheumatoid arthritis or lupus.

Here is how it works. Inside your body there is an amazing protection mechanism called the **immune system**. It is designed to defend you against millions of bacteria, viruses, toxins and parasites that would love to invade your body. Through a series of steps called the immune response, the immune system attacks organisms and substances that invade body systems and cause disease. When antigens (foreign substances) are detected, several types of cells work together to recognize these "invaders" and respond. These "protector" cells trigger other cells to produce antibodies. **Antibodies** (also known as **immunoglobulins**) are proteins that are found in blood or other bodily fluids and are used by the immune system to identify and neutralize foreign invaders. They are our body's "warriors". An **autoantibody** is an antibody (warrior) manufactured by our own immune system that attacks our own body and cells rather than fighting the "invaders". These autoantibodies are cells that are confused and wage war on our own system. There is a specific blood test, called an **ANA test**, that can measure the autoantibodies in our body. **ANAs (Anti-nuclear antibodies)** are autoantibodies that attack your own cells. They are present in higher than normal numbers in autoimmune disease. The ANA test measures the pattern and amount of autoantibody which can attack the body's tissues. Autoantibodies are present in low numbers in the general population, but their concentration is increased if you have an autoimmune disease. Through the Libby Epidemiological Research Project (LERP) which is lead by Dr. Steve Levin from (Mount Sinai School of Environmental & Occupational Medicine in New York) and Dr. Jean Pfau (Idaho State University) who will be conducting the research, CARD will be looking at the association of autoimmune disease and ARD.

CARD will be asking patients to voluntarily give a blood sample if they are interested in participating the project. People who have known autoimmune disease and those that do not are all invited to take part. In order to participate in any research project, individuals must sign a consent that explains the project purpose including the risks and benefits of taking part. Groundwork Required to Get Grants Funded

Kent State, the University of New York at Buffalo, and CARD are in the process of applying for a grant to develop a patient education and disease management program specific to Libby asbestos related diseases. But before we can submit the grant (to compete for funding to do the project) we need to do a little ground work. Important: Changing Asbestos Health Benefits in 2011

We all know that we have gone through many different asbestos health benefit programs in the last 10 years. Currently LAMP II and FLASH provide comprehensive ARD health benefits for diagnosed individuals. Because these programs are grant funded, they will be ending at some point in 2011, and the new long term asbestos health programs will be in place.

In 2010, legislation was passed to establish long term health programs in response to public health emergencies, such as the asbestos exposure that occurred in our community. There are three parts to this legislation 1) ongoing screening programs via grant funding, 2) traditional Medicare benefits and 3) establishment of a “pilot program.”

1) Ongoing asbestos health screening will be provided through a competitive grant process. Once the grant announcement is released, CARD will submit a proposal to continue screening for the time period specified in the grant.

2) Traditional Medicare benefits including Part A –inpatient services, Part B-out patient services, and Part D –prescription benefits (just like everyone gets when they turn 65) is available for eligible individuals. An eligible individual must prove they lived in Lincoln County for 6 months at least 10 years before they were diagnosed with an asbestos related disease.

3) At this point we cannot tell you what the “pilot program” will look like as the Center for Medicare Services (CMS) is currently developing it. The pilot program will not be the same as FLASH and enrollment will not be automatic as it was when people on LAMP were seamlessly rolled over onto FLASH. What we do know now is: 1) An application will have to be completed to get on the “pilot program” and 2) Eligibility criteria and the health benefits for this plan are still being defined by CMS.

The Bottom Line at this time:

- CARD will be there to help everyone through the transition as we have in the past.
- Medicare benefits combined with the “pilot program” will replace LAMP II and FLASH.
- Medicare and the Pilot program will not be exactly like FLASH and LAMP
- It is important to stay aware as the new benefits are being developed: we are hopeful that there will be a community meeting so we can give input to CMS from the community.
- CARD will do our best to keep you informed through CARD Newsletter as things progress.
- Be ready to do something in order to get the benefits you are entitled to have. CARD can not do it alone; we will need your involvement!


